- (viii) To hire, employ, pay, receive, train and make available instructors and education professional for the fulfillment of the above objectives.

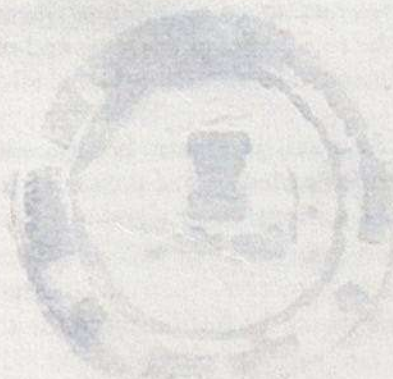



- F. To enter into agreements with other Indian and foreign based educational and allied institutions, colleges, schools, universities, etc, to evolve, start, run, take-over or adopt such programmes and for offering Diplomas, Certificates and Degrees as per the prevailing rules and systems.

WHEREAS in furtherance of its objects and aforesaid desire and for achieving other charitable educational motives and for other diverse good causes and considerations the SETTLOR has already set apart and handed over to the TRUSTEE the sum Rs.1,000/- (Rupees: One Thousand only) to be held by the TRUSTEE for the Foundation and to use it for and subject to the powers, provisions and stipulations hereinafter contained and declared of and concerning the same.

AND WHEREAS the said TRUSTEE has accepted the Trust and has agreed to act as the first TRUSTEE.

THIS DEED NOW THEREFORE WITNESSETH AS FOLLOWS:-

1. In pursuance of the said desire and for the purpose of educating the same and for the consideration aforesaid the SETTLOR does hereby declare that the SETTLOR had before the execution of these presents made over to the TRUSTEE the said sum of Rs. 1,000/- (Rupees: One Thousand only), the receipt whereof the TRUSTEE hereby acknowledge to have AND TO HOLD the same unto and to the use of the TRUSTEE upon the Foundation and with and subject to the powers and provisions hereinafter declared and contained and concerning the same.
2. The TRUSTEE shall stand possessed of the said cash of Rs.1,000/- and such further capital endowments or additions to Corpus and donations or contributions in cash or in kind as may be handed over to the TRUSTEE from time to time and all accretions thereto and income thereof respectively and the investment for the time being and from time to time representing the same or any part thereof together with conversions thereof and all other property and securities for the time being subject to these presents as hereinafter declared where the context so permits or admits, referred to as the Foundation funds, to collect and get in the income of the Foundation Funds, pay therefrom in the first instance all the proper costs charges and expenses of realising the same and management of the Foundation and Foundation Funds or otherwise payable there out and then upon Foundation and thereafter for the benefit of the beneficiaries with and subject to the powers and provisions hereinafter contained concerning the same.
3. The Trust hereby created shall be known as "OM CHARITABLE TRUST". In this indenture, it is for brevity's sake called the Foundation/Trust.

The Principal office of the Foundation shall be situated at 1/2, Prayag Street, Dwarika Prasad Road, District Allahabad. The TRUSTEE may close and open such branch office or offices of the Foundation at such other place or places as they may from time to time

That the SETTLOR, the first TRUSTEE and a maximum of three TRUSTEES, to be appointed in the first or the such earliest possible meeting of the Trust, shall, for all purpose and for all occasions as covered hereunder, be deemed to be the core TRUSTEE (hereinafter referred to as 'TRUSTEE') and will be on an equal footing for all responsibilities and rights except as hereinafter excepted.

Subject to the foregoing, the TRUSTEE shall hold the assets of the Foundation wholly for the above purpose and to apply the same to such purpose in India or outside India, which tend to help it achieve the above aims and objectives.

PROVIDED ALWAYS that the TRUSTEE shall not be bound to apply in any particular year for the purpose aforesaid the whole of the income which arises during the year end shall be at liberty to invest, if and however they think fit, the unexpended surplus (if any) in any of the investments hereby authorised and to accumulate the same and/or the resulting income thereof and the TRUSTEE shall be at liberty at any time in subsequent year or years to use apply the said accumulations and any part thereof for the purpose aforesaid.

If any capital endowments of additions to corpus in cash or in kind or any voluntary contributions or donations or subscriptions or legacies shall be made, paid or given for the purpose of these presents upon or subject to special conditions, it shall be lawful for the TRUSTEE to apply the same upon and subject to which conditions but not in derogation of the purposes for which the Trust is constituted otherwise as nearly as possible in conformity with the provisions of these presents contained.

The TRUSTEE may help by contributions, donations or otherwise to other institutions or trusts having allied or kind objects.

The TRUSTEE may purchase, acquire, hold, manage, improve, keep in repair, construct,

alter, develop, exchange, sell, lease, mortgage, charge, dispose off, turn to account or otherwise deal with all kinds of properties, moveable, and/or immovable, at their unfettered discretion and they may likewise vary or convert the same from time to time as they may seem expedient at their unfettered discretion..

The management and control of the affairs of the Foundation aforesaid shall be vested in the TRUSTEE with full power and absolute authority of the purpose of the administration of the Trusts aforesaid in such manner and subject to such rules and regulations and by-laws not inconsistent with or repugnant to any of the provisions thereof as the TRUSTEE may from time to time prescribe.

The TRUSTEE may from time to time open and maintain in their names a Banking account or accounts in such scheduled bank or banks as they may, from time to time, decide and may at any time pay or cause to be paid moneys of the Foundation to the credit of any such account or accounts or place or cause to be placed on deposit with any such bank or banks. The TRUSTEE may invest any moneys of the Foundation not immediately required for its investments or properties as from time to time determined upon by the TRUSTEE at their unfettered discretion and they may likely vary or convert the investments or the Foundation from time to time as may seem expedient at their unfettered discretion.

The TRUSTEE shall have the following additional powers:-

- A. Power to determine whether any money or property shall for the purpose of this Foundation be considered as corpus or income and whether out of the income of corpus and expenses outgoing or losses shall or sought to be paid or born and any and every such determination shall be binding and conclusive.
- B. The TRUSTEE may lodge for safe custody the share certificate, investment and other properties forming part of the Foundation funds and documents held by them relating to any property or to the Foundation under presents with any Banker or

- bankers on such terms as to the payment of their charges for the same as also for the withdrawal and deposit of securities and other matters as may from time to time be agreed upon between such banks and the TRUSTEE
- C. The TRUSTEE may in their discretion authorise such Bank(s) aforesaid, on such terms as to their remuneration as may from time to time be agreed upon to collect the interest, dividends and income of the Foundation funds and to credit the same to an account(s) of the TRUSTEE with the said or any other bank.
- D. At their uncontrolled discretion instead of acting personally to employ and pay any agent (including any bank) to do any act whatever in relations to the trusts of these presents including the receipt and payment of moneys without being liable for any loss and shall be entitled to be allowed and paid all charges and expenses thereby. Any TRUSTEE being a lawyer or engaged in any other profession or business shall be entitled to charge and be paid all usual professional or other charges for services rendered by him or his firm in relation to the Foundation premises or the trusts of these presents whether in the ordinary course of his profession or business and not and although not of a nature requiring the employment of a lawyer or other professional persons.
- E. The TRUSTEE may from time to time appoint upon such terms with or without remuneration as they may determine a Manager or managers, officers, clerks and other officials, caretaker and servant for any immovable property of the Trust, subject to the provisions of these Foundation, as the TRUSTEE may deem expedient for any of the purpose connected with these presents and may set apart rooms in the various building(s) subject to the provision of these Foundation as quarter whether free or otherwise for such caretakers and servants and may at any time remove any such Manager, officials, clerk, caretaker or servant.

- F. The TRUSTEE shall have full power to compromise or compute all petitions, suits and other proceeding and all differences and dispute touching the Foundation funds and/or the Foundation estate or arising out of these presents qua a third party and refer any such differences or dispute to Arbitration and to adjust and settle all account relating to the Foundation funds and/or the Foundation estate and to do all other acts, and things as fully and effectually as if they were absolutely entitled to the Foundation funds and/or the Foundation estate without being liable for any loss occasioned thereby.
- G. In the event of any disagreement/dispute touching upon any issue arising out of or touching upon the Trust, TRUSTEE in such dispute shall refer the matter to the other TRUSTEE and the decision of the majority of the TRUSTEE dealing with the issue, to the exclusion of the contesting TRUSTEE, shall be final and binding on all the parties.
- H. The TRUSTEE shall be entitled for any on behalf of the Foundation to enter into contracts or other engagement in the name of the Foundation or in any other names that may be adopted and it shall be sufficient, if any contract, deed, bills, cheque, assurance, receipt or other documents(s) required to be signed on behalf of the TRUSTEE are signed by a TRUSTEE or any person, officer or agent duly authorised in that behalf.
- I. The TRUSTEE may pay all taxes, charges and outgoing payable in respect of any immovable property for the time being forming part of the Foundation estate or assets and may carry out repairs which may from time to time be required to be done to the same and keep the same insured against loss or damage by fire and may incur all other costs, charges and expenses or and incidental to the administrator and management of the Foundation funds and the properties for the time being belonging to the Foundation as they in their absolute discretion think proper.
- J. The TRUSTEE may demise any immovable property or properties for the time being and from time to time belonging to the Foundation either from year to year or for any fixed term not exceeding three years or on monthly tenancies at such rents and subject to such covenants and terms as they may think proper, expedient and also accept surrenders of leases and tenancies and generally manage the same in such manner as they may think fit.

- K. The receipt of the TRUSTEE or any person or persons authorised in that behalf for any moneys, stocks, funds, shares, securities or investments paid delivered or transferred to them by virtue of these presents or in execution of the Foundation powers, therefore, shall effectually release and discharge the person payment, delivering and transferring the same therefrom and from being bound to see to the application or being answerable for the loss of misapplication.
- L. The TRUSTEE may raise or borrow money required or land or otherwise deal with moneys or properties belonging to the Foundation with or without any security and at such rate or rates of interest and on such terms as to repayment or otherwise as they may deem fit.
- M. The TRUSTEE shall be entitled at their discretion to sell convert any investments for the time being comprising of the Foundation funds and invest the net proceeds thereof as provided by these presents.
- N. The TRUSTEE may appoint/nominate such persons and committees, for such period as they may deem fit, for running various Schools, Colleges or Institutions. The said person/committee shall function under the supervision and control of the Board of TRUSTEE.
- O. If and so often as any of the TRUSTEE hereby appointed or any future TRUSTEE of these presents shall act against the interest or aims and objectives of or in competition to the work, ongoing or proposed, die or go to reside abroad or shall desire to retire or refuse or become unfit, insolvent or incapable to act in the Foundation of these presents, it shall be lawful for the SETTLOR in his life time or a majority of the TRUSTEE and after his death for the surviving or continuing TRUSTEE or TRUSTEES for the time being of these presents or if there shall be no surviving or continuing TRUSTEE or TRUSTEES or for his/her executor(s) or administrator(s) or legal representative of the last acting TRUSTEE to appoint any other person or persons to be a TRUSTEE or TRUSTEES in place of the TRUSTEE so dying or going to reside abroad or desiring to retire or refusing or becoming unfit, insolvent or incapable to act as aforesaid and upon every such appointment Foundation funds shall be so assigned, conveyed, assured and transferred as to become vested in the new TRUSTEE or TRUSTEES either jointly with the continuing TRUSTEE or TRUSTEES or solely as the case may require and every such new TRUSTEE or solely as the case may require and every new TRUSTEE or TRUSTEES (as well as before as after such transfer of the TRUSTEE funds) and shall have all the powers and authorities of the TRUSTEE or TRUSTEES in whose place he or they shall be substituted.

For any meeting of the Trust for taking any policy or other decision reasonable prior written notice will be given to all the TRUSTEE specifying the venue, date, time and the business to be transacted at such a meeting. At such a meeting even in the absence of the other TRUSTEE any two TRUSTEE present shall form the quorum for the meeting of the TRUSTEE.
- S. Proper books of accounts showing all receipts and disbursements had made on account of the Foundation hereby constituted shall be kept by the TRUSTEE and shall be duly audited with all necessary vouchers once at least in every year by such auditors as the TRUSTEE shall appoint and pay for the purpose.
- T. The TRUSTEE for the time being of these presents shall be respectively chargeable only for such money, stock, shares, funds and securities as they shall respectively actually receive notwithstanding their respectively signing any receipt for the sake of conformity and shall be answerable only for their own individual act, receipts, neglects or defaults and NEITHER for those of the other or others of them NOR any acts of defaults of any bankers, broker, Auctioneer, Agent or any other person with whom or into whose hands the Foundation funds or any part thereof or securities or the income thereof may be deposited or in the ordinary course of business come nor for lending money on any security with less than a marketable title not for the insufficiency, deficiency or description or any stocks, funds, shares or securities not for any mistake or error of judgment committed by them in regard to the choice of recipients of the help given by them nor, otherwise however unless the same shall happen through their own willful default or neglect respectively, nor for any other loss unless the same shall happen through their willful default respectively, and for which the other TRUSTEE shall keep him/her duly indemnified.



For any meeting of the Trust for taking any policy or other decision reasonable prior written notice will be given to all the TRUSTEE specifying the venue, date, time and the business to be transacted at such a meeting. At such a meeting even in the absence of the other TRUSTEE any two TRUSTEE present shall form the quorum for the meeting of the TRUSTEE.
- S. Proper books of accounts showing all receipts and disbursements had made on account of the Foundation hereby constituted shall be kept by the TRUSTEE and shall be duly audited with all necessary vouchers once at least in every year by such auditors as the TRUSTEE shall appoint and pay for the purpose.
- T. The TRUSTEE for the time being of these presents shall be respectively chargeable only for such money, stock, shares, funds and securities as they shall respectively actually receive notwithstanding their respectively signing any receipt for the sake of conformity and shall be answerable only for their own individual act, receipts, neglects or defaults and NEITHER for those of the other or others of them NOR any acts of defaults of any bankers, broker, Auctioneer, Agent or any other person with whom or into whose hands the Foundation funds or any part thereof or securities or the income thereof may be deposited or in the ordinary course of business come nor for lending money on any security with less than a marketable title not for the insufficiency, deficiency or description or any stocks, funds, shares or securities not for any mistake or error of judgment committed by them in regard to the choice of recipients of the help given by them nor, otherwise however unless the same shall happen through their own willful default or neglect respectively, nor for any other loss unless the same shall happen through their willful default respectively, and for which the other TRUSTEE shall keep him/her duly indemnified.

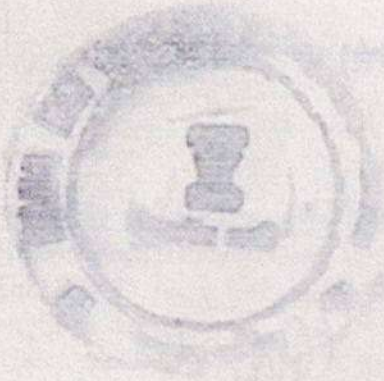
